

LOKAYUKTA HARYANA
FINAL REPORT FOR THE PERIOD 14.01.2011 TO 31.03.2011.

In continuation of the interim annual report for the period from 01.04.2010 to 13.01.2011 submitted by my learned predecessor Mr. Justice N.K. Sud, I have the honour to submit this consolidated final annual report on the administration of the Haryana Lokayukta Act, 2002 (for short the Act, 2002) for the remaining period with effect from 14.01.2011 to 31.03.2011 to His Excellency the Governor of Haryana as required under Section 17(3) of the Act, 2002 read with Rule 9 of the Haryana Lokayukta (Functions, Powers, Inquiry and Investigation) Rules, 2008.

It would be appropriate to mention here that I have taken over as Lokayukta, Haryana on 18th January, 2011. After my taking over, this office received as many as 97 complaints upto 31.03.2011, the details of which are given in Annexure-I. During this aforesaid period i.e. 18.01.2011 to 31.03.2011 89 complaints have been disposed of. In that regard, the details are shown in Annexure-II. Out of these disposed of complaints, the Government has submitted its action taken report as required under Section 17(2) of the Act, 2002. The details of the same are shown in Annexure-III. At this stage it is also pertinent to mention that in complaint No. 163 of 2009 recommendation to transfer Shri Ashok Bansal, Assistant Food & Supplies Officer was made as he was sitting for the last about 20 years in district

Sirsa. He was shown to have created his vested interest and ultimately the Government accepted the recommendation and transferred him from Sirsa to Bahadurgarh (Jhajjar). Further, the details of the complaints in which action taken report is yet to be received have been shown in Annexure-IV.

During the course of taking down the proceedings in most of the complaints it has been brought to my notice by the staff of Lokayukta that in most of the complaints action taken reports are not being sent in time by the departments concerned i.e. within three months as required under Section 17(2) of the Act, 2002.

Herein this report I would also draw kind attention of His Excellency the Governor of Haryana that in order to achieve the objects and aims of the Act, 2002, the following amendments, if made, can make this Act more effective.

SUO MOTU COGNIZANCE

In fact, under the Haryana Lokayukta Act, 1997 (for short the Act, 1997), there was a provision of taking suo motu cognizance of allegation and grievance under Section 8(1) of the said Act, 1997. This provision also exists in the States of Karnataka, Maharashtra and Rajasthan. But now, the same stands repealed under the present Act, 2002.

POWER TO PUNISH FOR ITS OWN CONTEMPT

In the earlier Act, 1997 there was also provision of power with the Lokayukta to punish for its own contempt under Section 15 of the said Act, 1997 in the matter of summon of record, serving attendance of witnesses and upholding of its dignity and for that purpose the provisions of Contempt of Courts Act, 1971 were made applicable. But now under this new Act, 2002 that provision has also been taken away, whereas this provision is available in the Lokayukta Acts of Karnataka, Kerala, Mahdya Pradesh and Himachal Pradesh.

LIMITATION

In the earlier Act, 1997 there was also a clause providing the prescribed period of limitation of 10 years for initiating the action in the matter of allegations. But under the Act, 2002, no such period of limitation has been prescribed and as such the complaints are being filed even in respect of the matters where cause of action had arisen long back. Thus, it is suggested that to keep check on highly belated and vexatious complaints, a limitation period in the matter of allegations should be prescribed for five years whereas in the matter of grievances it should be restricted upto one year. However, a clause should also be inserted to condone the delay in the matters where sufficient and bonafide cause is shown for not making the complaint within the specified

time. Such provisions are also there in the Lokayukta Acts in the States of Kerala, Maharashtra, Rajasthan, U.P. and Delhi etc

RE-HEARING/ REVIEW

In the Act, 2002, there is no provision for re-hearing or to make review of its order even for justified reason or order passed exparte. Thus, it is recommended that in the interest of equity, good conscience and justice a provision should be added in the Act under which re-hearing/ review in the matters already decided by the Lokayukta could be made. This provision also exists under Rule 39 chapter 9 of the Maharashtra Lokayukta Rules, 1974.

DESTRUCTION OF RECORDS

It is also suggested that under the Act, 2002 there is no provision to weed out the old records. In this connection, it is submitted that a rule should be framed under this Act for the destruction of old record of more than three years after retaining a copy of the original complaint and the final order passed therein. This provision also exists in Rule 42 under Chapter 9 of the Maharashtra Lokayukta Rules, 1971.

It would not be out of place to mention here that during the course of enquiry/ investigation of the complaints, it has been observed that in most of the matters/ representations made by the aggrieved persons to the higher authorities, the decisions are not taken promptly. When efforts were made by

this office to ascertain the reason for delayed decisions on such matters, no valid or any justified reason could be pointed out by the officers dealing with such matters. This tendency, to my mind, on the part of the responsible officers not only erodes the faith of the aggrieved persons, rather it breeds corruption and also amounts to an act of maladministration. In this regard, it is suggested that the concerned highest authority in the State administration should take corrective measures and make out some mechanism to curb this tendency of sitting over the files/ papers for months together.

REMOVAL OF ANOMALY IN PAY STRUCTURE OF THE LOKAYUKTA INSTITUTION

One more factor which is of great importance and also affecting the working of this Institution negatively is the disparity / anomaly in pay structure/ scales allowed to the employees of this Institution. At the time of commencement of this Institution it was kept at par with five superior Government Departments/ Bodies i.e. Haryana Civil Secretariat, FCR's office, HPSC, Haryana Vidhan Sabha and office of the L.R., in terms of Pay Scales purportedly agreeing to the factors material in this regard. Later on, at different points of time, the pay scales of many of categories in aforesaid five superior Departments were upwardly revised by the Government but this Institution was kept deprived of the same. This Institution pleaded, in due course, many of times in past to get the pay scale position restored with those offices but unfortunately the Competent Authorities have not paid any heed

towards it and the matter has been lying pending for a long time with them. In view of lower pay scales and consequent financial loss, employees from these aforesaid five Departments are not willing to join this office on deputation basis and as such due to shortage of staff the work of this Institution has been suffering badly. It is, therefore, suggested that the old established pay parity of this Institution with such five superior Departments may be restored immediately.

After my taking over as Lokayukta, I have tried my best to ensure that the grievances and complaints made by the complainants in this office are dealt with in a fair and judicial manner and, necessary recommendations, wherever required for taking corrective measures have been made in order to eradicate corruption and maladministration so as to promote transparency in the working of the Governmental machinery for strengthening the faith of the people in the administration of the State.
